

Wolfpack Elite Youth Sports Coaching Contract

1. The head coach must be at least 21 years of age. All assistant coaches are Appointed by the head coach of each team and must be at least 18 years of age.
2. Coach trainees will be allowed if age 16 or over, with the consent of the Association President. These persons must conduct all coaching under the supervision of at least one of the assistant coaches, and may not have unsupervised Contact with players.
3. The head coach is responsible for the actions of the assistant coaches, parents and team players, prior to, during and after each game, practice and league event.
4. If a head coach or one of his assistants is penalized for un-sportsman-like behavior, the head coach will be put on probation for the remainder of the season and is subject to further action taken by the President and/or the Board of Directors per the WOLFPACK ELITE YOUTH SPORTS bylaws. Action could result in the head coach being relieved of all coaching duties.
5. A head coach or assistant coach can be removed from their duties if the Board of Directors agrees in a majority vote that said coach's actions are detrimental to the welfare of Wolfpack Elite Sports.
6. Each head coach is required to maintain accurate records of all player rosters, equipment issues, player contracts, medical release, parent/guardian information such as street address, phone numbers, general comments and emergency information. Two books will be required to be maintained. One book created by the team staff will be on file and the other turned in to the Conference that the WEYS participates in.
7. At least two members of the coaching staff must carry verification of First Aid certification and Concussion Training certification.
8. If an injured player cannot get up on his/her own power, emergency medical aid will be summoned.
9. If a grievance is filed, it must be filed addressed to the association president and emailed wolfpackeliteports@gmail.com by the Monday following the game in question. The Executive Board will decide appropriate action to be taken.
10. Team rosters submitted to the league at verification will be final and no additions will be accepted. Failure to comply with this rule will result in a forfeiture of all games said player participated in, and disciplinary action to head coach of said team.

Background Check completed and individual is approved to coach.

Coach completed concussion training CDC.gov

Coach is First Aid/ CPR certified.

Coach completed the USA Football online program.

Coach completed the on-field training with association's PSC.

11. The bench area is reserved for players and coaches. Sidelines are specifically for medical personnel and chain crews only. The team box is between the 25-yard lines and a minimum of 2 yards from the playing surface.

12. Foul and abusive language used by any coach or player will not be tolerated.

13. Although not enforced, it is strongly suggested that each eligible player plays a minimum of 5-0 plays per game.

14. If a player is ineligible to play in a game due to injury or disciplinary reasons, they must be on a list turned in via email @ wolfpackeliteports@gmail.com to the association no later than Friday @ NOON before their next game.. If a player appears on that list they must not play in the game at all, but are encouraged to be dressed out in athletic gear and jersey to support their team.

15. Intentionally running up scores will not be tolerated. If, at any time, our teams are up on an opponent by more than 35 points, we must do our best to show good sportsmanship.

16. The head coach is responsible for knowledge of the rules as defined by the National Federation of High Schools, Georgia High School Rules and the current Youth conference rules.

17. The coaches will commit to all training sessions, meetings and clinics specified by the executive board.

18. The head coach is responsible for proper use of equipment. The required equipment consists of game jerseys, pants, appropriate pads, shoulder pads, mouthpieces, and NOCSAE approved helmet.

19. All coaches must be able to pass a comprehensive background check completed for each coach prior to any contact with players. Cost of screening will be paid by the coach,

I will foster among the members of the team, the ideal of good sportsmanship, citizenship, and character and provide a positive example for others.
